NOTES FROM THE LAST HOA MEETING... ... June 12. 2008

Reminder Residents: Real Estate Signs are only allowed in the common areas during the weekend. Please remove your signs on Sunday evening!

- Dick Toskes provided the board with an update on the financial status of the association which
 is currently in very good shape and indicated that there were no unusual expenditures for the
 month. Key expenditures for the month did include payments for pool management, overall
 management services and our lawn service. We also paid for the removal of trees at the
 Holliman playground area.
- Dennis Weiss presented a gift certificate to homeowner Bernard Cordeau to thank him for installing a cement walkway at the pool to gain entrance to the new shed.
- The board has received several email complaints concerning the pool and pavilion area near the pool. Two homeowners also attended the board meeting to express their concerns. A rather lengthy discussion was held concerning persons gaining access to the pool who may not live within the community, uninvited guess, and persons entering the pool but not signing in or showing a pass and rough playing within the pool. After the discussion, the board decided that a meeting (Joy Nyman and Connie Bender to represent the board) would be held immediately with pool management to address our concerns, that the life guards would be advised that all persons entering the pool must show a pass and that the throwing of objects (balls, etc.) would be banned in the adult pool area.

If these actions do not correct the concerns then consideration would be given to adding an additional guard at the pool with the specific duties of checking pool passes. At present we have a teen (on weekends) whose job is to check passes so that our guards can concentrate on watching the pool area.

The board has made it clear that they will take whatever actions are necessary to make our pool area safe and enjoyable for all homeowners within the community.

Another homeowner is working on having the appropriate policing authorities attend our a board meeting to address other concerns of safety and improper conduct around the pavilion

area once we have been provided with the name of the contact at the Police Department who represents our neighborhood.

- A homeowner also indicated that several mothers would like to see additional playground equipment installed at the playground near the pavilion. It was agreed that these mothers would make recommendations to the board as to what additional playground equipment would be preferable.
- The painting of the new street post will be carried over to the July/August board meeting; these posts can not be painted until about four months of installation.
- Dave Hering indicated that all pool repairs had been completed by Metro Group. A second weed control application has been completed by Tilley's and Tilley's has completed the plantings at the entrance sign near Dick's and that Tilley's has also completed the installation of irrigation and new sod at the Holliman playground area.
- The board received a second bid for the plantings and landscaping to be completed at the Sherwin and Wylie four corners. The board decided to hold off with this item until the fall due to the hot weather.
- The board did approve the power washing of the white fencing along the Holliman playground area and Virginia Center Parkway (entire fence both inside and outside for \$650.00). Subsequent to the meeting, the power washing of the fencing has been completed.
- President Dennis Weiss submitted his resignation to the board since he is relocating outside our community. The board thanked Dennis for his years of service and presented Dennis with a gift certificate to thank him for his many hours of community service.
- The board then approved the nomination of Bernard Cordeau to the board to serve out the remaining term of prior President Dennis Weiss.
- Board member Eric Wilder was then selected to serve as the new Board President and Becky Davis to serve as Vice-President.

We meet the second Thursday of every month. Residents are strongly encouraged to attend. These meetings are a great place to get up to date on the happenings in the neighborhood and a forum to express any concerns, questions, or compliments. All meetings follow Roberts Rules of Order. Pool Season is fully underway!

Based on the complaints that were received regarding pool activities, Connie Bender and Joy Nyman met with Swim Metro Management to reinforce having pool passes checked upon entry to the pool as well as having residents sign in. Please make sure you and your family adhere to the following reminders below:

- You must sign in and show your pool pass every time you visit the pool.
- All guests must have guest passes and any additional guests over the (2) per household, will be charged \$5.00 each.
- Lifequards have the authority to limit the use of pool toys being used in the pool, in addition, we do not want objects (balls, etc.) to be thrown in and around the adult pool.
- Children 12 years old and under are not allowed at the pool without an adult 16 years or older. **Do not** send your children to the pool alone, nor leave them alone when you are at the pool.
